The mission of FISH/Friends in Service to Humanity of NWCT is to meet the most basic of human needs – food, shelter and hope. Since opening its doors in 1972, FISH has evolved into the largest emergency homeless shelter, covering the geographic area of northwestern Connecticut, by providing families, individuals and veterans a safe and secure haven. In addition, FISH serves local communities as a food pantry that is open four days a week.

The goals and objectives of the agency reflect our work – at the shelter, food pantry, and emergency fuel/energy – recognizing the very human, social welfare challenges of families, individuals and veterans by collaborating, partnering and outreaching to officials and other social service providers. Our goal is to give those in need the tools and resources needed to gain independence successfully.

At the shelter, residents are served by a case manager who is devoted to making our residents independent through economic/employment resources and educational opportunities.

FISH NWCT offers GED instruction, life skills workshops, and opportunities for vocational certification at NCCC, as well as mental health and medical care weekly. The diversity of residents includes newborns through seniors. The shelter strives to be a family friendly, communal home.

At the FISH Food Pantry, we ensure that hundreds of families are able to receive their life sustaining food needs. Our goal is to provide a friendly and safe place to our neighbors in need. We know that our program and social services are critical to some for their survival.

Amazing things happen for people under the roof at FISH, and we welcome you to assist us in our mission for serving those neighbors in economic crisis and facing life challenges. We depend on the generosity of our community!

FISH FACTS in 2018:

FISH Food Pantry – Total meals distributed = 116,569

of families enrolled to receive assistance = 516; representing 1779 individuals

FISH Emergency Homeless Shelter – Total #of bed nights = 11,714

This represented 102 individuals – 85 adults, 6 children, and 11 veterans, with 41 shelter residents moving into permanent supportive housing.

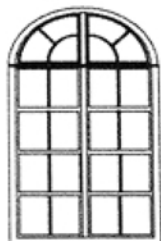

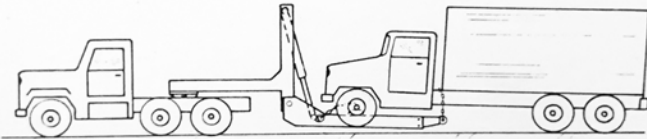
